KAKA'AKO GUIDING PRINCIPLES DEVELOPMENT EXERCISE

ROAD MAP

- 1. At the May meeting, examples of guiding principles, words, phrases and images that were generated at previous meetings were distributed as handouts for review.
- 2. Before June 10 CPAC meeting all previously generated material related to developing Guiding Principles will be sorted, organized into themes and posted on the HCDA website.
- 3. At the June 10 CPAC meeting the facilitators will review the vision work to date, the definition and process to develop guiding principles, and the organization of the previous CPAC work into broad theme areas:
 - a. Environment
 - b. Community
 - c. Cultural
 - d. Education
 - e. Financial viability/Sustainability
- 4. The broad theme titles will be on large posters around the room, where break-out groups will work together to write and nominate guiding principles for each theme.
- 5. To form the break-out groups, each CPAC participants will self-select a one theme area they want to work on. Within their group, participants will write and nominate guiding principle items in a way that gives planning and design guidance for that theme area. The nominations from each group will be written on chart paper so that others in the room can read it.
- 6. Half way through the time allotted for guiding principles, participants will have the option to make one rotation to a different self-selected theme area and will use the same process as step #5 to develop additional principles (They may comment on original guiding principles but cannot change or delete them.).
- 7. After the June 10 CPAC meeting the compiled draft "Guiding Principles" will be posted on the HCDA website for the all CPAC participants to review.
- 8. CPAC participants may review these and nominate other Guiding Principles by sending nominations to the facilitators by email smoke@hawaii.edu or fax 956-9121 by June 27 at noon. Along with the June 10 Guiding Principles, all of the new Guiding Principle nominations made by individuals will be posted on the HCDA website by July 1.

- 9. CPAC participants will prepare for the July 8 meeting by reviewing and choosing the Guiding Principles they feel will best guide the future of Kaka`ako Makai; they should come to the July 8 meeting prepared to vote on the Guiding Principles which they want to continue to refine.
- 10. At the July 8 meeting all of the nominations in each theme area will be posted on large posters around the room. Participants will be given multiple dots to use to express their preferences for guiding principles in each bin or theme area. The group will work to reach consensus about the Guiding Principles that will become part of the recommendation to HCDA.
- 11. At the second July meeting, CPAC will review the chosen guiding principles and return to finalize the vision statement for Kaka`ako Makai. We are currently proposing a second July meeting for CPAC approval because of the probability that some families will be traveling in August. The proposed purpose of the meeting would be to review the chosen guiding principles and return to finalize the vision statement.

DEFINITION OF A GUIDING PRINCIPLE:

Statement expressing a core commitment to either a preferred design element for the Kaka`ako Makai area or a process for the collaborative development and evaluation of design elements.
