POINT PANIC SITE VISIT NOTICE

CPAC participants, Steering Committee members and Kaka‘ako Makai shoreline users are invited to meet at Point Panic at 5:00 PM on Tuesday, December 9, to evaluate the site for the proposed addition of two statues as a memorial to Mother Marianne Cope. The memorial is proposed to be located within the circle beneath the tree on the Point.

Background:

On September 29, 2008 the Sisters of St. Francis requested permission from the Hawaii Community Development Authority (HCDA) to erect a statue in memory of Mother Marianne Cope at the Point Panic lookout to commemorate her work in Kaka‘ako and Molokai on behalf of leprosy patients. At the HCDA monthly meeting on November 5, HCDA staff presented the proposal as an information item.

At the next HCDA meeting on December 3, HCDA staff recommended that the HCDA board approve the request. It was noted that the CPAC had not been presented with this proposal, and the HCDA’s action was deferred so the CPAC could have this opportunity. The HCDA will consider the CPAC’s recommendation on the proposal at their next meeting on January 7, 2009.

All those interested in and/or affected by this potential addition to the Point Panic lookout are invited to provide comments at the December 9 site visit. The next regular CPAC meeting will be on December 16, at 5:30 PM at the John A. Burns School of Medicine, Room 301, where HCDA Executive Director Anthony Ching will provide an overview of the proposed project. The information gathered from the December 9 meeting will then be presented for discussion, and the CPAC will determine a recommendation at that time. All CPAC meetings are open to the public.
